# BIG CHANGES IN 1976

The S.E.B.A. ANNUAL GENERAL MEETING will be held in the Meeting Room of the ABC Bowl, Bexleyheath on SATURDAY, 31st JANUARY 1976 assembling at 7p.m. for a 7.30p.m. start. This issue of Bowling News concentrates on the Meeting which is the first run under the new electoral system agreed by the Delegates at the last A.G.M. No more will Area Officers be co-opted onto the Area Council but will now be proposed and seconded from their own Bowling Centre and voted in at the A.G.M. Candidates in this respect are required to obtain a proposer and a seconder and be an ordinary member of B.T.B.A. in good standing and bowl in a league within the jurisdiction of S.E.B.A. through which he is registered with B.T.B.A. ALL SUCH NOMINATIONS MUST BE SENT TO THE AREA PRESIDENT, 176, MAIN ROAD, SIDCUP, KENT to be received by Midnight th January 1976. Candidates will be required to attend a meeting of the S.E.B.A. Nomination Committee at Bexleyheath on Saturday, th January at 7.30p.m. accompanied by their Proposer or Seconder. Non attendence will result in the candidate's name not being put forward for vote at the A.G.M. A proposer and secondar can back only one candidate. Candidates will be asked whether they have the time to devote to Area affairs and will be able to ettend meetings regularly, whether they are willing to abide by the decision of the majority and be willing to back such a decision even if, they themselves, do not personally agree with it, whether they consider themselves capable of working with people and to always be a good to always act in the security of ficer. The example and always act in a manner befitting an Executive Officer. The candidate should be the type of person who enjoys meeting fellow bowlers and helping them to solve their problems and should understand that he serves without pay and that his rewards are friendship and the opportunity to put back something into the sport of bowling by being one of a group of congenial and devoted bowling leaders of S.E.B.A.

# DELEGATES & AMENDMENTS TO AREA

Each sancthosedclasges within S.E.B.A. is entitled to one Delegate and one Alternate at the A.S.M. The Delegate carries the vote of the league that he represents and the Alternate acts for him if he cannot attend or has to leave during the meeting. Only the Delegate, or the Alternate in his absence, may speak on behalf of his league.

Every S.E.B.A. league should elect their Delegate and Alternate whose names must be in the hands of the Area Secretary at 111, Vigilant Way, Gravesand, Kent by Midnight on 17th January 1976. Applications

should take the following form:-

Any proposed amendments to the Area Bye-laws can only be put forward through a Delegate at the A.G.M. Any such amendment must be presented to the Area Executive c/o 111, Vigilant Way, Gravesend, Kent by Midnight on 17th January 1976. These will be considered by the Legal and Legislative Committee of S.E.B.A. prior to the A.G.M. and their recommendments will be given to the Delegates at the A.S.M. for their vote as to acceptance or otherwise.

REBORT OF LEGAL SUB COMMITTEE CHAIRMAN

Any matters that have been brought before the Legal Committee during the year will be indicated and the outcome given.

REPORT OF TOURNAMENT SUB COMMITTEE CHAIRMAN

The Sub Committee's views upon the last Area Chempionships will be given together with details of the 1976 Chempionships. He will provide dateils to Delegates of tournaments that have been planned, considered or run and will advise as to future events.

REPORT OF AWARDS SUB COMMITTEE CHAIRMAN

The Chairman will report to Delegates upon the efforts made to recover the permanent trophies from the Southend Area of the BTBA and upon the introduction of an Area Award Scheme that does not duplicate any existing scheme. He will indicate the problems of ever rising costs with regard to badges and will introduce a certificate scheme for such as the annual Area Hi's, King Keglers and New Year Award recipients etc etc.

12 . REPORT OF NOMINATIONS SUB COMMITTEE CHAIRMAN

> In accordance with the agreed motion passed by the Delegates at the 1974 A.G.M. members of the local council will be elected at each A.G.M. of the Board of Directors (Delegates) of S.E.B.A. To be eligible for nomination and election to the S.E.B.A. Council those named must mest the following requirements:-

(a) Must be an Ordinary Member of BTBA in good standing and have

paid membership dues within 30 days of the election.

(b) Bowl in a league within the jurisdiction of the South Eastern Bowling Association through which he is registered with BTBA.

Candidates for election to the Local Council of S.E.B.A. shall seek nomination at centre level. Candicates may be adopted by the following methods:-

(a) Adoption by Ordinary Members. (b) Adoption by the league through which he is registered with BTBA. (c) Adoption by League Officers, meeting at the centre at which he regularly bowls. Being nominated by the Chairman of such a meeting and seconded by a Delegate. Where more than one candidate is candidate is nominated at such a meeting, each candidate shall be nominated be nominated and seconded by different Delegates.

n.b. It is preferred, but not compulsory, that Proposers and/or It is preferred, but not compulsory, Seconders are DELEGATES to the 5.E.B.A. Annual General Meeting.

Candidates shall attend the A.G.M. of 5:E.B.A. unless due notice in writing has been given 7(seven) days prior to the meeting stating the reason for paparattends. the reason for non-attendance. Proposers and/or Seconders shall attend the A.G.M. of G.F.P. attend the A.G.M. of S.E.B.A. either as a Delegate, Alternate or

All nominations shall be signed by the Proposer and Seconder. The Candidate shall also sign an acceptance of the Nomination. All Nominations shall be sent to the Area President(see front page) and be in his hands by Midnight on 17th January 1976. Nominations received after this date shall be null and void.

The election at the A.G.M. will be conducted by the Chairman. Where the number of Candidates exceeds the number allowed by the Area Constitution a vote by the Delegates shall take place by show of the Delegate's Vote Cards upon each of the Candidates. The Candidate who receives the greatest number of votes shall be the most successful down to the one who is successful in filling the last post with the least number of votes. However if the number of Candidates required is not received all will be returned unopposed and no vote will be required.

In accordance with the Area Constitution Delegates are entitled to carry one vote for every 5(five) members who have joined the BTBA through their league as at 31st August 1975.
